Trans Globe became an international operator through its farm-in at Nuqta in the Arab Republic of Egypt ("Egypt") in July 2004, attaining an objective the Company's management team had focused on for a number of years. Additional acquisitions in Egypt, notably in the West Gharib area, followed in 2007 and 2008. Trans Globe's team quickly demonstrated its significant technical and operational skills, applying technology and capital to the low-risk, development-

oriented fields and achieving production increases in short order. In January 2010, Trans Globe farmed in on a 50% working interest in the East Ghazala Concession in the Western Desert of Egypt. In March 2011, Trans Globe announced the signing of a Sale and Purchase Agreement to acquire a 100% working interest in the West Bakr Concession agreement in Egypt from The Egyptian Petroleum Development Co. Ltd. (of Japan), subject to customary due diligence, closing conditions and the approval of the Egyptian Government.
